2024 Fall Residential Heating & Air Conditioning Rebate Program Contractor Participation Overview

Rebates will be offered on full heat pump, central air conditioning systems, or mini split heat pump system. For heat pump systems, the outdoor unit and indoor air handler must be installed. For central air conditioning systems, the outdoor unit, indoor fan-bearing unit or furnace, and coil must be installed. *Add-on coils alone are not eligible for a rebate*. For mini split heat pump systems, both the outdoor unit and indoor unit(s) must be installed. Rebates are based on AHRI Type noted on AHRI Certificate. EAP rebates are not valid in combination with other manufacturer rebates or discounts. PECO and local utility rebates can be combined with EAP rebates.

Additional \$250 on a dual fuel heat pump (hybrid): Heat Pump Efficiency must meet rebate level minimums (see above) - this is NOT a separate rebate, just an additional amount. For dual fuel heat pump, outdoor unit, indoor coil, and furnace must be installed.
